EXCELLENCE IN SAFETY AWARD

The **CCS Excellence in Safety Award** is designed to acknowledge companies that demonstrate outstanding safety performance through the execution of written safety programs and documented safety records. It is the highest honor that CCS can bestow on a company.

A panel of volunteer judges will review all entries which will include the submission document, safety statistics and site inspection report. The top five are recognized as Safety Leaders then compete for the coveted “Crystal Eagle” Excellence in Safety Award.

Winners will be announced at the 25th Annual CCS Anniversary and Awards Celebration on *Wednesday, May 2, 2018* at the Indiana State Museum.

Qualifying companies must be involved on a construction team:

- General and Prime Contractors
- Subcontractors
- Construction Managers
- Developers

Note: Applicants for the Excellence in Safety Award will compete against all companies. There are no categories. All companies who the judges deem meet the criteria will receive a Safety Achievement Award. The top five will be recognized with a Safety Leader Award with the top company being recognized as the Excellence in Safety winner.

Narrative

- The narrative is a set of five (5) questions that the entrant must answer to demonstrate how the company is addressing safety performance.
- The purpose of the narrative is to give your organization the ability to explain to the judges how your company distinguishes itself with regard to safety programs and why your company should be considered for the industry’s highest safety award.
- The total length of the narrative must not exceed five (5) pages.

- Submission must include:
 - **award application**
 - five (5) page **narrative**
 - **jobsites list**
 - **safety statistics form (if not in the CCS Certification Program)**
- All submissions must be submitted electronically in **one PDF document**.
- In addition, please include your company logo in .jpg or .tif format.
- *Any departure from the guidelines will be considered incomplete and may result in the judges deeming the entry invalid.*

- Submissions must be received no later than **Friday, February 2, 2018 at 5 p.m. EST.**

1. What indicators do you use to evaluate your safety performance and what do you do with the data?
2. How does your company instill a safety ethic throughout your organization?
3. What are your processes (both internally and externally) to ensure safe conditions when working with multiple employers on a job site?
4. What are you doing as a company to advance workplace safety not only in your own organization but also in the industry?
5. Describe your company's efforts to continually improve safety through implementation of new initiatives or through actual safety performance and provide details of said improvements.
