



25th Annual CCS Anniversary and Awards Celebration

ZERO INJURY AWARD

The **CCS Zero Injury Award** is given to companies whose craft persons working for the company have not suffered a work-related incident resulting in loss of consciousness, restriction of work or motion, transfer to another job or requiring medical treatment other than first aid for the past calendar year.

The winners will be announced at the 25th Annual CCS Anniversary and Awards Celebration on *Wednesday, May 2, 2018* at the Indiana State Museum. ***A representative of the nominated company must be present at the Awards Celebration to accept the award.***

A panel of judges will review the submissions to verify the safety statistics and affirm the applicant's commitment to safety.

2017 OSHA 300A Log

The Zero Injury criteria must be substantiated by no incidents being recorded in 2017 in columns G, H, I and J on the company's OSHA 300A log. The submission must include the company's 2017 OSHA 300A log. ***If the company is current in the CCS Certification Program, the log does not need to be provided.***

Eligibility and Submission Requirements

- Company must be a CCS Association Member or a current participant in the CCS Certification Program.
- Submission must include: **award application** and **OSHA 300A log for 2017**.
- All submissions must be submitted electronically in **one PDF document**.
- In addition, please include your company logo in .jpg or .tif format.
- Company **MUST** have a representative attend the CCS Awards Celebration and be registered no later than April 13, 2018 to be eligible to receive the award.
- *Any departure from the guidelines will be considered incomplete and may result in the judges deeming the entry invalid.*

- Submissions must be received no later than **Friday, March 2, 2018 at 5 p.m. EST**.
