Incident Number	Date	Incident Narrative
1	6/2018	Employee was lowering pipe when the anchor point failed and employee was struck in the leg by the pipe causing a fractured leg.
2	6/2018	Employee was walking across some larger diameter stone and rolled his ankle.
3	6/2018	Not an Indiana based claim : Fatality due to a motor vehicle collision between our field service trucks and a semi-tractor trailer pulling a load where the driver was fataly injured.
4	6/2018	Employee tripped while walking, grabbed a steel stud to balance himself, cutting his finger that required stitches to repair.
5	6/2018	Employee injured right shoulder when striking excavator counterweight.
6	6/2018	Employee was putting a cabinet in a dumpster when a metal staple cut her forearm.
7	6/2018	Employee fell into uncovered manhole that was densely covered with ground foliage causing a laceration to the right shin.
8	6/2018	Employee suffered a cut to the head when while using a wrench it slipped striking her in the head.
9	6/2018	Employee was relocating a ladder and slipped on concrete slurry, as he fell he reached out to brace his fall and cut his forearm on stud framing.
10	6/2018	Employee was leaning on wood beam complaining of pain in torso, ended up being fractured rib.
11	6/2018	Employee had a foreign object in eye while walking through jobsite not performing task.
