Incident Number	Date	Incident Narrative
1	4/2020	Technician received 2nd degree chemical burns to both hands
2	4/2020	Employee working on lift and moved within travel of crane, lift was tipped over causing them an ankle fracture.
3	4/2020	Employee walking on wet/muddy ground on right of way to move truck slipped causing a spiral fracture of right tibia.
4	4/2020	Employee was driving a boom lift and where there were large holes on the concrete covered by a sheet of plywood. There was a sign to advise of issue. Employee did not see the sign and drove over the plywood and into the hole. The tire collapsed in the hole and he fell forward and hit is mouth on a safety bar and broke his dentures.
5	4/2020	Employee was in the middle of hanging pipe on a boom lift and he pinched his ring finger on his left hand on the lift and peeled his finger.
6	4/2020	An employee's fingers were caught in a spinning drill, where they lost 2 fingertips.
7	4/2020	Employee strained his back while bending over to pick up welding hood.
