Incident Number	Date	Incident Narrative
1	5/2023	(I) Employee strained his right knee while sending an email on his company phone walking.
2	5/2023	(I) When removing ceiling grid, the employee was trying to rip off wall mold from masonry wall (that was tension pinned) with his hands instead of using pry bar. This resulted in lacerations of the second, third, fourth and fifth palmar digits of right hand.
3	5/2023	(I) Employee picked up a box and felt a pop in his lower back. This resulted in a strained lower back.
4	5/2023	(I) Employee's foot was run over while operating a lift.
5	5/2023	(I) Employee cut his shoulder on a piece of metal on an OSR rack.
6	5/2023	(I) Two employees were moving pipe around and one employee's hand was smashed between some pipes.
7	5/2023	(I) Crew members team lifting vacuum into truck. Injured employee felt pain in shoulder when team lifting vacuum into truck.
8	5/2023	(J) Drilling hole for conduit in wall when hole saw caught glove and pulled hand into hole saw resulting in a laceration to hand.
9	5/2023	(J) Employees were assisting the insulation contractor in identifying a hot water tracer leak to allow for a repair. Upon energizing the tracer, the affected employee was struck by hot water (180 F). The bleed ball valve (left open by others/unknown date and time) with no plug in place, located directly above the supply valve being opened sprayed hot water to portions of the right hand, right arm, and right torso. This resulted in burns to arm and upper body.
10	5/2023	(J) Employee was standing on spoil pile and spoils gave out, employee reached with left arm to break fall resulting in a non-displaced left shoulder fracture.
11	5/2023	(J) Employee had right hand under piece of rebar for support as the ties were being cut. When the tie was cut, the rear dropped causing superior labral tear of right shoulder.
12	5/2023	(J) A 28-year-old carpenter strained his back moving material to work area for cutting and installation metal studs. While using 3 people to move material to work area for cutting and installation, employee stated all three were lifting with their legs utilizing proper lift technique for material handling, he took a step backwards feeling/hearing a pop then pain.
13	5/2023	(J) Drilling duct work and drill slipped resulting in a shoulder strain.
14	5/2023	(J) While using a ratchet strap, the strap snapped & hit the employee in the arm resulting in a cut.
