1	6/2023	(H) Employee received electrical shock from contact with power lines.	
2 6/2023		(H) Employee was injured in truck rollover accident.	
3 6/2023		(H) Employee was pulling cable into conduit and his left foot got caught in cable causing pain. Resulted in left ankle/foot strain.	
4 6/2023		(H) Employee was involved in an auto incident	
5 6/2023		(H) The employee is unable to feel pain in his feet due to a pre-employment injury. He couldn't tell his feet were getting so hot which lead to getting severe blistering.	
6 6/2023		(I) Dropped equipment on toe resulting in an open wound and fracture.	
7 6/2023		(I) Employee parked a boom lift under another boom lift being used. When the operator came back to move the parked boom, he hit the boom being used and the employee was caught between the lift & struts.	
8 6/2023		(I) Employee felt a pop in his back while hanging pipe overhead.	
9	6/2023	(I) Employee missed a step while descending a ladder and twisted his leg.	
10 6/2023		(I) While pulling on a wrench, felt a pop in his back/chest.	
11 6/2023		(I) Employee was cutting a piece of pipe with a band saw and the blade came in contact with his finger.	
12 6/2023		(I) As employee was using a pipe threader, his glove got caught while it was spinning and pulled his finger between the pipe & the reamer.	
13	6/2023	(I) Employee was operating a scissor from the ground and ran over his foot.	
14	6/2023	(I) pressurized hot water line broke resulting in employee tripping over scaffold base resulting in injury to groin	
15	6/2023	(J) Employee received a laceration when his finger got caught between 2 pieces of metal. He was wearing gloves.	
16	6/2023	(J) Employee was using self-purchased noncut gloves in a cut application and lacerated the back of his hand.	
17	6/2023	(J) Employee using grinder and lacerated finger.	
18	6/2023	(J) Employee was in the way of plywood being dropped down resulted in ankle contusion.	
19	6/2023	(J) Employee experienced an induced voltage incident while installing jumper.	
20	6/2023	(J) Employee was installing insulator and the top broke off causing laceration.	
21	6/2023	(J) Employee was exiting cab of truck, lost his balance, and pinched left middle finger.	
22	6/2023	(J) Employee was exiting the job trailer and the door swung back closed and struck him in the back causing pain and discomfort. Resulted in fractured disk.	
23	6/2023	(J) Employee cut hand while cutting EMT for support stakes.	

24	6/2023	(J) Lifting basket while extending duct hangers, slid finger on top of rail cutting. Resulted in fractured left ring finger.	
25	6/2023	(J) Struck Finger on scissor lift causing fractured fingertip.	
26	6/2023	(J) Employee was using a knife to do work, and the knife slipped and cut employee on the wrist, requiring stitches.	
27	6/2023	(J) Employee slipped and landed on sharp edge of cable tray resulting in a laceration.
