1	11/2023	(H) Employee was walking and tore left achilles.
2	11/2023	(H) Employee was walking down metal stairs, lost his footing, and fell striking his left shoulder causing a shoulder dislocation.
3	11/2023	(I) Employee dislocated/tore shoulder.
4	11/2023	(I) Employee strained back while loading, unloading, and installing wood doors.
5	11/2023	(I) Employee was carrying a ladder that got caught on hanging electrical cords and pulled his shoulder.
6	11/2023	(I) Employee was cutting pipe with a bandsaw and it jumped and cut his finger.
7	11/2023	(J) Employee was using a portable bandsaw to cut material and struck finger. They were not wearing gloves. Injury requiring stitches.
8	11/2023	(J) Employee was using 6 inch reciprocating saw and got a laceration to the leg.
9	11/2023	(J) Employee cut finger while cutting plywood with a skill saw requiring stitches.
10	11/2023	(J) Employee was driving conduit stake in the ground with Sledgehammer - Smashed left index finger.
11	11/2023	(J) Employee received a tuft fracture on the end of the right middle finger. The employee's finger was inadvertently closed in a steel door on a pressurized building.
12	11/2023	(J) Employee was in the process of positioning cam on an engine and right index finger was contacted causing laceration.
13	11/2023	(J) Employee cut his index finger pulling on a fish tape.
14	11/2023	(J) Employee had metal object in hand after tripping & falling.
15	11/2023	(J) Employee felt pop in left calf after stepping from concrete to a pile of dirt.
16	11/2023	(J) Employee fell off curb, landed on dirt pile, hard dirt ball w/ rocks hit patients sternum, landed face down on right rib.
17	11/2023	(J) Employee was using an air want to clean up debris and dust blew in her eyes.
18	11/2023	(J) Employee was moving a pallet and pulled his right shoulder.
19	11/2023	(J) Cutting a short rod and cut though the rod, hand slipped. Resulting in stitches.
