Incident Number	Date	Incident Narrative
1	4/2024	(I) Employee tore left quadricep tendon when lifting an object.
2	4/2024	(J) Employee cut finger with band saw while cutting pipe and tripod slipped.
3	4/2024	(J) Employee fractured toe after load on crane dropped on their foot.
4	4/2024	(J) Employee received a laceration to the back of right hand.
5	4/2024	(J) Employee received laceration to right thumb.
6	4/2024	(J) Using grinder to cut rebar in awkward position. Grinder kicked back and cut fingers.
7	4/2024	(J) Wrecking formwork with Crowbar. Missed the edge of the formwork, momentum forward caused hand to strike the edge of framework lacerating the top of the finger.
8	4/2024	(J) Installing metal scaffold pan overhead and pulled it forward allowing it to come off of the back support and falling striking rear of left lower leg resulting in a laceration.
9	4/2024	(J) Employee broke rib.
10	4/2024	(J) The employee was coming down on the lift and his right hand came in contact with a piece of spiral duct work resulting in laceration.
11	4/2024	(J) Employee was cutting a tree top that was laying on a communication line. As he was removing the tree top, a branch struck his lower lip causing laceration.
12	4/2024	(J) Employee was lifting an 8' fiberglass crossarm overhead to place in the digger truck and felt pain in his left shoulder.
13	4/2024	(J) Fractured hand on a Kubota Buggy.
14	4/2024	(J) Employee was driving concrete form pin and struck wrist with sledge hammer.
15	4/2024	(J) Employee was working with rebar baskets when the basket contacted the back side of their arm causing a laceration.
16	4/2024	(J) Employee was cutting pipe & a piece fell on onto his foot.
17	4/2024	(J) Employee was installing pipe & felt a pop in his groin area.
18	4/2024	(J) Employee got out of a UTV and his foot got wedged on the curb of the ramp he was walking up, lost his balance and fell off the ramp.
19	4/2024	(J) Employee was using a drill bit to clean the tip of a caulk gun that slipped and went through the web of skin between the thumb & finger.
20	4/2024	(J) Employee was drilling a hole into concrete and debris got into his goggles.
21	4/2024	(J) Employee was installing fittings and one fell off and hit him in the mouth.
22	4/2024	(J) Employee's glove got caught and pulled into a groover.
23	4/2024	(J) Employee fractured right leg.
24	4/2024	(J) Employee stroked his left hand index finger through his A5 cut resistant glove with and 6" Dewalt Grinder, resulting in a cut/laceration.
