1	5/2024	(I) Employee hurt his back while lifting argon bottles.	
2	5/2024	(I) Employee developed a fatty hernia.	
3	5/2024	(J) A team member was driving a tracked dump truck and hit a bump. He felt pain in his lower back and requested to be seen by a medical professional. He was diagnosed with a sprained back.	
4	5/2024	(J) Pinched finger assembling cup scaffold.	
5	5/2024	(J) Employee was cleaning out a small back door on the tailgate of dump truck. When he went to close the door on the tailgate, he pinched his right pinky finger between the handle and a stopper plate causing a laceration.	
6	5/2024	(J) Employee received a laceration to right palm of hand from a piece of angle iron.	
7	5/2024	(J) Employee received laceration to left hand index finger while cutting threaded rod with reciprocating saw.	
8	5/2024	(J) Employee was walking and stepped in a hole resulting in a fractured foot bone.	
9	5/2024	(J) Employee was pulling fish tape with lineman pliers when the pliers slipped off and hit him in the mouth.	
10	5/2024	(J) Employee was loading pipe onto a cart and as he put the handle back on the cart, it slipped and hit him in the chin.	
11	5/2024	(J) While unloading transformer mounts from a push cart, one of the mounts shifted on the cart and pinched the employee's finger between the mount and the support bar on the cart.	
12	5/2024	(J) While carpenter was helping to unload drywall/lumber, the cart they were using tipped over on top of employee, who wasn't wearing his hard hat at the time. He had a minor facial fracture.
