1	6/2024	(I) Employee experienced elbow tendonitis in a result from material handling.
2	6/2024	(I) Employee was prepping insulator strings, rigging and running tag line to control insulators being raised to crew in the air and felt effects of the heat.
3	6/2024	(I) Employee experienced paresthesia of left upper extremity.
4	6/2024	(I) Assisting another trade, employee lifted item to move it and heard a pop in right arm.
5	6/2024	(J) Employee pinched finger between boom lift top rail and fascia board causing laceration/fracture.
6	6/2024	(J) Employee pinched fingers between steel siding and masonry wall causing laceration.
7	6/2024	(J) Employee cut finger with portable bandsaw, holding material with one hand and bandsaw in the other.
8	6/2024	(J) Employee was cutting masonry weep with a utility knife, knife slipped and cut finger.
9	6/2024	(J)Employee was grabbing masonry block off a frame scaffold, as it was being turned the employee's finger was pinched between the block and scaffold frame causing fracture.
10	6/2024	(J) Employee was sawing off a piece of pipe above his head. When pipe was completely cut thru it fell and hit the employee below his lip.
11	6/2024	(J) Employee was welding debris and fell into right eye.
12	6/2024	(J) Employee was attempting to straighten out a bent rail on scissor lift using a sledgehammer which bounced off rail striking employee on mouth.
13	6/2024	(J) Employee was stepping over beam caught foot causing trip and fall, landed on outstretched arms fracturing right humerus.
14	6/2024	(J) Employee was approaching pressure washer to refuel with a portable gas can. When he opened the latch of the gas can, there was an ignition source causing a fire resulting in burns to his left hand and arm.
15	6/2024	(J) Employee was stepping onto the steps of digger from the bellow of the truck. While maintaining 3 points of contact, his foot slipped and he fell, striking his face and left elbow causing pain.
16	6/2024	(J) Employee was cutting a tree during storm work and as he was manipulating the tree limb off the line, he felt discomfort in his right shoulder.
17	6/2024	(J) Employee was removing elbow fittings from shipping box lost control of fitting hitting himself in the elbow cutting his arm.
18	6/2024	(J) Employee was using his hand to try and smack adjustable elbow cutting palm of hand.
19	6/2024	(J) Employee received medication related to mental health treatment following witnessing violence at a jobsite.
20	6/2024	(J) Employee was picking up pipe when he lost his balance on loose stone which caused him to fall.
21	6/2024	(J) Employee was descending a ladder and missed a rung and fell.
22	6/2024	(J) Employee leaned onto a pipe that was on the eject table of the weld station and fell.
23	6/2024	(J) A steel plate struck employee in the forehead.

24	6/2024	(J) Broderson outrigger placed onto employee's foot.
25	6/2024	(J) HVAC worker cut thumb on fan blade.
26	6/2024	(J) Employee was working from a leaned 6' step ladder, as he was descending the ladder the bottom slipped forcing him to jump from the ladder landing flat footed on the ground below at which point the employee sprained his right knee.
