Incident Number	Date	Incident Narrative		
1	7/2024	(I) Team member tripped and fell backward, hitting his head against a hitch on a dump truck. The contact caused a laceration that needed stitches to close.		
2	7/2024	(I) Employee's bicep gave out when lifting duct onto lift resulting in a left bicep strain.		
3	7/2024	(I) Employee stepped on manual lift tailgate and broke their ankle.		
4	7/2024	(I) Employee assisting another trade in moving wooden steps, heard pop in right arm resulting in surgery.		
5	7/2024	(I) Two employees were hanging pipe above joists. While the employee was putting the pipe in the joist, the pipe hit the other employees hand causing a laceration.		
6	7/2024	(I) Employee was involved in a vehicle accident that resulted in injuries. Since he was driving a company vehicle during working hours, the incident was reported as both vehicle and recordable.		
7	7/2024	(J) Employee tripped on the curb, fell forward & caught himself with his arms and hands, resulted in bilateral fracture radius'.		
8	7/2024	(J) Employee's glove got caught in drill bit resulted in finger needing splinted.		
9	7/2024	(J) Employee using razor knife to cut soft flooring when knife went off track and cut thumb.		
10	7/2024	(J) Employee using a tiger paw sanding wheel on a grinder to buff down the wild of a pipe. The employee lost control of the tool and it came back and cut his index finger. He was wearing cut resistant gloves, but it cut through.		
11	7/2024	(J) Laceration to the employee's head. The employee received 4 sutures.		
12	7/2024	(J) Employee cut right hand moving piece of flat metal.		
13	7/2024	(J) Employee was cutting a metal box clamp with circular saw resulting in a laceration to left middle finger.		
14	7/2024	(J) Employee was preparing to cut conduit on an open tailgate of a work truck when the conduit rolled off and struck his right foot causing pain.		
15	7/2024	(J) Employee was exiting water truck over matted bridge while maintaining three points of contact. As he stepped down, his boot went into a gap of broken mat and he rolled his left ankle causing pain.		
16	7/2024	(J) During storm restoration, employee was cutting excess wire off the secondary service when the uncontrolled tail sprung back and struck his right eye under his safety glasses causing pain.		
17	7/2024	(J) Employee was canting pole when the cant hook slipped, he fell down the embankment causing a laceration on his right elbow.		
18	7/2024	(J) Employee was on a customer roof, it started to rain suddenly. There is a gap between the platform and the building on one side. On the adjacent side of the platform was a chest high wall and another section of roof level with the platform. Employee was trying to transition back over the wall from the roof to the platform. He didn't want to use the extension ladder due to concerns of the rungs being slippery and wet. He put his foot on top of the wall to move diagonally from roof to platform. Slipped on the plastic covering of the wall, fell away from the gap and fell on his sternum on top of the chest high wall, bounce over to platform landing on his feet.		
19	7/2024	(J) Employee was rotating/adjusting LB conduit body when they heard right elbow pop. Ended with torn bicep.		

20	7/2024	(J) Employee twisted ankle while walking.	
21	7/2024	(J) Apprentice suffered a fractured foot at LTC while attempting to remove a fan motor thru a doorway.	
22	7/2024	(J) Employee was pulling braided hoses out of a sink and as the hose came loose a stainless bracket cut the employee's arm.	
23	7/2024	(J) Employee was adjusting an expansion valve in a tight location and the wrench slipped and hit him in the hand causing a laceration.	
24	7/2024	(J) Employee was replacing a flange, and his hand slipped causing it to get cut on the end of the pipe.	
25	7/2024	(J) Employee cracked teeth due to dropped scaffold pole striking them in mouth.	
26	7/2024	(J) While cutting through snow fence with a box cutter, a laborer lacerated his leg.	
27	7/2024	(J) While a carpenter was cleaning drywall knives, one slipped & lacerated hand.
