Incident Number	Date	Incident Narrative		
1	4/2025	(H) Employee jumped from upper level and got leg pinned resulting in a fracture.		
1	4/2020	(H) The employee was working off a work platform that was attached to the		
2	4/2025	concrete forms for basement walls. The work platform was 11 feet and 5 inches above the ground. He was measuring forms to ensure they were plumb and leaning on a 2x4 hand rail at the end of the platform. As he leaned on the railing, the railing gave way, and he fell to concrete foundation below. He was transported to the Emergency Room and diagnosed with a broken left femur.		
3	4/2025	(H) Employee involved in vehicle head on collision resulting in employee hospitalization and other person. Collison resulted in a dislocated right shoulder and fractured vertebra.		
4	4/2025	(I) Employee fell on roof that was covered in ice while retrieving material. This resulted in broken and bruised ribs.		
5	4/2025	(I) Employee jumped into 36" deep trench and sprained left knee.		
6	4/2025	(I) Employee was using a box knife to pry drywall that had become lodged inside of a hole saw blade when the knife slipped and struck his thumb causing a laceration.		
7	4/2025	(I) Employee was pushing a cart when the wheel hit a crack in the floor causing the pipe to shift and pinching his hand between the cart and pipe resulting in a laceration.		
8	4/2025	5 (I) Fractured right ring finger when pinched between stones when manually moving.		
9	4/2025	(J) Employee was working on chipping concrete from a 6ft ladder. Employee descended the ladder and stepped down onto a piece of concrete that had been chipped out rolling their ankle.		
10	4/2025	5 (J) Laceration to finger. The end of employee's finger was struck by T post driver that missed the post.		
11	4/2025	(J) While climbing a ladder employee experienced cramp in right ankle.		
12	4/2025	(J) Employee missed the bottom rung of a ladder and caught his forearm on a data rack resulting in a laceration.		
13	4/2025	(J) Removing a fan causing laceration to fingertip.		
14	4/2025	(J) Employee cut thumb with knife.		
15	4/2025	(J) Team member was removing concrete forms when his arm slipped and he cut himself on a piece of pencil rod.		
16	4/2025	(J) Employee cut hand while using utility knife.		
17	4/2025	(J) Employee cut finger while using utility knife.
