



OUTSTANDING CRAFTSPERSON AWARD

The **Outstanding Craftsperson Award** gives every CCS Association member company the opportunity to publicly honor a craftsperson for their safety efforts.

Each company may determine their own criteria for the awards. Every person whose application is received will win the award; however, **each company is limited to only one honoree.**

The awards will be announced at the Annual CCS Awards Celebration on *April 23, 2026* at the Scottish Rite Cathedral. Winners will receive a choice of either a Columbia Watertight II or a Carhartt jacket embroidered with the CCS logo along with "Outstanding Craftsperson 2026" and the recipient's name.

All nominees should be present at the Awards Celebration so that they will be able to be recognized and accept the award in person.
