



## ZERO INJURY AWARD

The **CCS Zero Injury Award** is given to companies whose craft persons working for the company have not suffered a work-related incident resulting in loss of consciousness, restriction of work or motion, transfer to another job or requiring medical treatment other than first aid for the past calendar year.

The winners will be announced at the Annual CCS Awards Celebration on *April 23, 2026* at the Scottish Rite Cathedral. ***A representative of the nominated company must be present at the Awards Celebration to accept the award.***

### 2025 OSHA 300A Log

The Zero Injury criteria must be substantiated by no incidents being recorded in 2025 in columns G, H, I and J on the company's OSHA 300A log. The submission must include the company's 2025 OSHA 300A log.

## Eligibility and Submission Requirements

- Company must be a CCS Association Member or a current participant in the CCS Certification Program.
- Submission must include: **award application** and **OSHA 300A log for 2025**.
- All submissions must be submitted electronically in **one PDF document**.
- In addition, please include your company logo in .jpg or .tif format.
- **Company MUST have a representative attend the CCS Awards Celebration and be registered no later than April 3, 2026 to be eligible to receive the award.**
- *Any departure from the guidelines will be considered incomplete and may result in the judges deeming the entry invalid.*
